Course Description:

LIT 2000 Introduction to Literature (3)(A.A.)

Three hours per week. Prerequisites: ENC 1101 and concurrent registration in or completion of ENC 1102 with a grade of “C” or better. This course meets the Area IV requirement for A.A./A.S. general education, the Gordon Rule requirement, and part of the six-hour International/Intercultural requirement. This course provides a close inspection into literary techniques, conventions, and genres in literature with emphasis on historical, cultural, analytical, and theoretical contexts.

Our Section of LIT 2000:

LIT 2000 Introduction to Literature Fairytales Spring 2022 will meet course objectives through reading, discussion, and research based in fairytales. Students will perform literary analyses upon multiple forms of these stories, working to recognize types, variants, and common tropes, as well as the extensive history and contemporary cultural context for the stories and storytellers. As students examine narrative strategies and genre expectations, they will be faced with the interplay between cultural expectations and resistance to cultural norming. This examination will occur within online discussion, college level analytical writing, creative writing, and application of scholarly research.

2. Analyze the conventions of literature and its various sub-genres, as evidenced by select texts, with an in-depth focus and inquiry into one literary movement or genre.
3. Evaluate critical and theoretical issues contained in secondary scholarship.
4. Apply the appropriate vocabulary for the study of literature.
5. Demonstrate college-level reading skills through textual analysis, including the detection of tone, bias, stereotypes, and underlying assumptions.
6. Demonstrate college-level writing skills by creating an original thesis and including primary and secondary source material in a variety of writing assignments, including one or more formal, research-based assignments.
7. Access, evaluate, and apply information sources in an ethical manner for research and problem solving, and demonstrate the ability to retrieve and manage information using digital technology.
8. Apply technological skills necessary for academic work, including but not limited to email, dropboxes, and discussion forums.
9. Demonstrate the ability to effectively interact with peers in group discussions and other activities.
10. Demonstrate an understanding of aesthetic expressions in the literary works of culturally diverse authors and literary movements.
11. Fulfill the writing requirements mandated by SBE 6A-10.

Attendance Policy:

Each instructional module has specific due dates for assignments provided in the individual assessments. Attendance for this course, and for each module is considered to be completion of the course assessments (discussions, quizzes, journals, and other assignments) by the due date. Each assessment has a due date provided which is accessible via the Syllabus page or the course modules.

While students do not actually attend an online class at particular times, I am still required to account for student attendance in the online course for student financial aid purposes. Passive activities such as login to the course and checking on a course grades are not sufficient.

Therefore, the following tasks will count for attendance events:

Attendance in this class is defined as completion of the original “Post” in a discussion forum for the week and

Attendance in this class is defined as completion of each quiz and

Attendance in this class is defined as completion of the fairy tale and final essay

NOTE- More than a week without attendance via completion of an assignment may result in a student's withdrawal from the course.

This attendance event is particularly important for federal financial aid to determine the Last Day of Attendance (LDA). The last completed attendance event will be recorded as the students LDA.

Attendance/Assignments Policy:

New financial aid rules dictate strict standards for attendance, so please pay close attention to the current attendance policy. Keep in mind that your attendance in any of your courses could have direct consequences on your financial aid.

While we are experiencing a pandemic, regular attendance is still necessary for the student's success. If there are problems with attendance due to major illness, death in the family, or family emergency, please contact me as soon as possible. There may be a way to avoid the withdrawal. The auto withdrawal is at my discretion and will be dealt with on a case-by-case basis.

No-Show Policy:

Students who do not drop a course that they have never attended will be reported as a No-Show by the course instructor during the No-Show period. This drop may have financial aid implications for the student who is dropped.

Grading Policy:

NOTE: All the assignments listed in Course Assignments must be completed in order to pass the course. Assignments must be put into dropbox in the required format (doc or docx) in order to receive credit. Corrupt or empty files will receive a zero.

Grades and assignment notes can be found in Canvas. Notes will be added to assignments within the dropbox comments and sometimes within the submitted texts as annotation. Discussions may receive notes via the discussion board. Current grades will be available in the Canvas gradebook; please note that grades are numerical, a percentage out of 1000 points total. (810 points=81%=B).

Late Work:

Papers put into dropbox one to two days (24-48 hrs) after the due date may lose at least 25-75% of their point value, depending on how late they are and the quality of the work. Late assignments may not be accepted after the third day of tardiness. Dropbox will lock. Late essays will not receive comments, only a grade.

Incomplete Paper Policy: Any paper that does not reach the assigned minimum length will be given an automatic grade of F (50%) and can go down from there.

Plagiarized Essay Policy: Any essay deemed to be plagiarized or improperly cited will result in a zero on the assignment and possible withdrawal from the course. Plagiarism is cheating. Please

Discussion (4@ 300= 1200+ words, 35 points each) 140 points (clear analytical discourse with citation to the text, includes responding to fellow students, may use “I”)

Fairy Tale (1500+ words) 150 points (creative synthesis of themes, settings presented in college level writing with few to zero spelling or grammar errors)

Final Paper (1800+ words) 250 points (thoughtful analysis integrated with multiple examples of critical scholarship with few to zero spelling or grammar errors, citation to assigned texts only, no use of “I”)

There are 1000 points total. You must complete all assignments AND earn at least 700 points to pass the course, as well as writing 6000+ words as assigned. There is no set extra credit, but it could happen.

Students are required to communicate with their instructor using their official SCF email address.

Gordon Rule:

This course meets the Florida State Board of Education Rule Number 6A-10.30. In accordance with this rule, students will complete six semester hours of English and six semester hours of additional coursework in which the student must demonstrate college-level writing skills. SCF requires a minimum of 6,000 words in each of these Gordon Rule courses. A grade of C or better is required for credit in Gordon Rule classes.

Withdrawal Policies:

A withdrawal is a change in the student's course schedule where one or more courses are withdrawn before the end of the term. Withdrawn courses appear on the student's transcript as a "W" and are classified as attempts. No refunds are permitted for withdrawn courses.

Withdrawing from a course(s) - Course withdrawal is defined as withdrawal from one or more classes for a term but not complete withdrawal from the college. **Failure to completely process a drop form or drop a class online may result in the student being assigned a grade of "F".**
